

## INVITATION TO BID FOR

### ***HYBRID YELLOW CORN SEEDS SUBSIDY PROGRAM UNDER THE LOCAL GOVERNMENT UNIT OF ANAO***

1. The *Local Government Unit of Anao, Tarlac*, through the *SPF- Seed Subsidy Program* intends to apply the sum of *Two Hundred Seventy Thousand Pesos (270,000.00)* being the Approved Budget for the Contract (ABC) to payments under the contract for *Hybrid Yellow Corn Seeds Subsidy Program Under the Local Government Unit of Anao*. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Local Government Unit of Anao, Tarlac* now invites bids for *Hybrid Yellow Corn Seeds Subsidy Program under the Local Government Unit of Anao*. Delivery of the Goods is required on *September 2017*. Bidders should have completed, within *ten (10) years* from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from *the LGU Anao, Tarlac* and inspect the Bidding Documents at the address given below from *8:00AM to 5:00 PM*.
5. A complete set of Bidding Documents may be acquired by interested Bidders on *July 27, 2017* from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of *Five Hundred Pesos (P500.00)*.
6. Bids must be duly received by the BAC Secretariat at the address below on or before *August 15, 2017*. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause Error! Reference source not found..**

Bid opening shall be on *August 15, 2017, 10:00 A.M.* at *the Mayor's Conference Room*. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

7. The *Local Government Unit of Anao, Tarlac* reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
